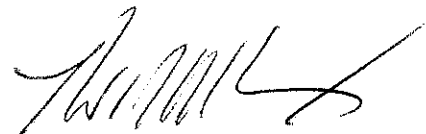

SUBJECT: Proposition A Transit Fund Exchange and Assignment Agreement

INTRODUCTION

As in past years, the City of Lakewood has surplus Proposition A (Prop A) Transit Funds that exceed current operational needs and may be exchanged for General Fund monies. Conversely, the City of West Hollywood has transit-related needs beyond its available fund allocation and has expressed interest in acquiring Prop A funds from the City of Lakewood.

STATEMENT OF FACTS

Since 2010, the City has exchanged surplus Prop A funds annually with various cities in the region. In recent years, the exchange has been with the cities of Manhattan Beach and West Hollywood.


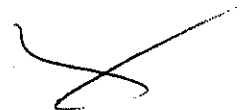
The City of Lakewood receives approximately \$1.5 million annually in Prop A funds. The City of West Hollywood is requesting an exchange of \$1 million in accumulated Prop A funds for \$700,000 of their General Fund monies. Therefore, the exchange would be at \$.70 of General Fund monies for every one dollar in Prop A funds. This rate is consistent with that of other exchanges in the county.

STAFF RECOMMENDATION

It is recommended that the City Council approve the Proposition A Transit Fund Exchange and Assignment Agreement with the City of West Hollywood, and authorize the City Manager and Director of Finance & Administrative Services to execute the Agreement.

ASSIGNMENT AGREEMENT
PROP A LOCAL RETURN FUND EXCHANGE

This Assignment Agreement is made and entered into this 16th day of March, 2020, by the City of West Hollywood, California and the 10th day of March, 2020 by the City of Lakewood, California with respect to the following facts:

A. The City of West Hollywood provides two community shuttles, demand-response services as well as bus pass and taxi subsidies to serve people with disabilities and the general public. Given the grave traffic congestion and parking problems of the City, West Hollywood is committed to reducing auto dependency by providing alternative modes of transportation. Adequate Proposition A Local Return funding for transit services is not available given the limited amount of West Hollywood's Local Return allocation and the needs of other priority transit projects in the City.

B. The City of Lakewood has uncommitted Proposition A Local Return funds which could be made available to West Hollywood to assist in providing the services discussed in Paragraph A of this Agreement. In exchange for the assignment by West Hollywood of the amount of its general funds indicated in Section 1 below, the City of Lakewood is willing to assign uncommitted Proposition A Local Return funds to West Hollywood for the purpose identified in Paragraph A.

Now, therefore, in consideration of the mutual benefits to be derived by the parties and of the premises herein contained, it is mutually agreed as follows:

1. Exchange. The City of Lakewood agrees to assign a total of \$1,000,000 of its Proposition A Local Return funds to West Hollywood. \$149,653 of this total is from Fiscal Year 2019-2020. The balance of \$850,347 are funds allocated from the 2018-2019 Fiscal Year. In return, West Hollywood agrees to assign \$700,000 of its general funds to the City of Lakewood. The exchange rate is \$.70/\$1.00.

2. Consideration. The City of Lakewood shall assign the agreed upon Proposition A Local Return funds to West Hollywood in one lump-sum payment. West Hollywood shall assign the agreed upon general funds to the City of Lakewood in one lump-sum payment. The payments shall be due and payable upon execution of this Agreement, and upon approval by Los Angeles County Metropolitan Transportation Authority (LACMTA) of the City of West Hollywood's project description. Each payment shall be based on the exchange rate in accordance with the exchange rate described in Paragraph 1 (above).

3. Term. This Agreement is effective on the date above written and for such time as is necessary for both parties to complete their mutual obligations under this Agreement.

4. Termination. Termination of this Agreement may be made by either party so long as written notice of intent to terminate is given to the other party at least five (5) days prior to the termination.

5. Notice. Notices shall be given pursuant to this Agreement by personal service on the party to be notified, or by written notice upon such party deposited in the custody of the United States Postal Service addressed as follows:

6. Assurances

A. West Hollywood shall use the assigned Proposition A Local Return funds only for the purpose of providing the services discussed in Paragraph A of this Agreement and within the time limits specified in LAC Metro's Proposition A Local Return Program Guidelines.

B. Concurrently with the execution of this Agreement, West Hollywood shall provide LAC Metro with the Standard Assurances and Understandings Regarding Receipt and Use of Proposition A funds specified in the Guidelines regarding the use of the assigned Proposition A Local Return funds.

SUBJECT: Participant Agreement for the Los Angeles Region Imagery Acquisition Consortium 6 (LARIAC6)

INTRODUCTION

The County of Los Angeles oversees the Los Angeles Region Imagery Acquisition Consortium ("LARIAC6") project. LARIAC6 was established to provide member cities with considerable cost savings related to the acquisition and use of color digital orthophotography (aerial imagery). By participating in LARIAC6, the City of Lakewood ("City") would be able to update its aerial imagery and integrate it, and related data, into its Geographical Information System (GIS). The FY 2019-2020 budget includes a partial appropriation for the acquisition and integration of the digital imagery provided by LARIAC6.

STATEMENT OF FACTS

Digital orthophotography is aerial imagery that has been accurately corrected to ground terrain with the aid of geodetic surveying and photogrammetry. Technological advances in computer hardware, software and storage capacity now allow the large volumes of data created by digital orthophotography to be processed at a reasonable cost. By participating in the LARIAC6 consortium, the City will once again enjoy substantial cost savings due to the consortium's ability to proportionately spread costs across its members.

As with the previous consortium (LARIAC5) project, the LARIAC6 project will provide the City with high resolution aerial imagery that includes the greater Lakewood region, oblique aerial imagery, and exclusive access to online and mobile aerial mapping applications at no additional cost. LARIAC6 will also provide participants with color infrared aerial imagery, building outlines GIS data, annual aerial imagery updates through 2022, and continued access to historical aerial imagery.

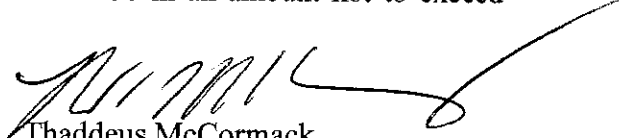
The City of Lakewood's cost to participate in LARIAC6 is not to exceed \$27,434. LARIAC6 is accepting payments from multiple fiscal years to reduce the budget impact of a single, large payment. The FY 2019-2020 budget allotted \$13,717 for the initial 50% deposit. FY 2020-2021 funds will include the remaining 50% balance of \$13,717 to be paid upon the delivery of the digital data in FY2020-2021.

RECOMMENDATION

That the City Council authorize the City Manager to execute the Participant Agreement for the Los Angeles Region Imagery Acquisition Consortium Program LARIAC6 in an amount not to exceed \$27,434 subject to approval as to form by the City Attorney.

This Participant Agreement (Agreement) is made and entered into by and between the County of Los Angeles (County), a political subdivision of the State of California, and **City of Lakewood**, a California city, special district, agency, or educational institution. Each individual city, district, educational institution, or agency is referred to herein individually as a "Participating Entity" and collectively as the "Participating Entities". The County and the Participating Entities are hereinafter referred to collectively as the "Parties" and each individually as a "Party".

- A. **WHEREAS**, County has planned to acquire new digital orthogonal and oblique aerial imagery in the winter of 2020 Project;
- B. **WHEREAS**, County has become aware that various Participating Entities have similar projects currently underway or plans to undertake similar projects in the near future;
- C. **WHEREAS**, in order to avoid the duplication of efforts and costs by the Parties, the Parties desire to pool their resources to collectively undertake the Project; and
- D. **WHEREAS**, the Parties intend to participate in the Project upon the terms and conditions set forth herein below.

NOW, THEREFORE, in consideration of the mutual covenants herein set forth and the mutual benefits to be derived therefrom, the Parties agree as follows:

1. Purpose

The purpose of this Agreement is to provide a vehicle for the collective participation in the Project by the Parties. The Project shall focus on the acquisition of certain aerial imagery digital data which may include, but are not limited to, products listed in Attachment A ("Digital Data"). It is the intent of the Parties that Digital Data shall be acquired under this Agreement for areas within the County of Los Angeles covered by the jurisdictions of the Parties.

2. Responsibilities of the County

- A. Identify and provide specifications for Digital Data (or their derivatives) to the contractors hired to complete the Project.
- B. Develop all necessary procurement documents for necessary services to be provided by one or more qualified contractors in connection with the acquisition and administration of the Digital Data.
- C. Select the most qualified contractor or contractors to provide the necessary services in connection with the acquisition and administration of the Digital Data and thereafter, manage the entire acquisition and administration of the Project.
- D. With the assistance of one or more selected contractors, provide Quality Control (QC) for all Digital Data delivered under this Agreement.
- E. Arrange for the delivery of the Digital Data (or portions thereof) to the Participating Entity upon Project completion.
- F. Provide monthly reports to the Participating Entities on the status of the Project.

3. The Participating Entity Has the Right to

- A. Participate in identifying and providing technical specifications for the Digital Data (or their derivatives).
- B. Provide currently available geodetic points (with necessary standards and accuracy) for County's QC process.
- D. Acquire additional digital aerial products from the contractors through this agreement, provided that a Statement of Work is provided. County assumes no liability for the completion of these products.

4. Mutual Responsibilities; Maximum Contribution

The Parties shall be mutually responsible for the following:

- A. Financing the acquisition and administration of the Digital Data including, but not limited to, costs related to QC and the subsequent distribution thereof. The total cost of such acquisition and administration (Total Cost) shall be allocated among the Parties and the Participating Entities. The portion of the Total Cost allocated to a Party hereunder shall be hereinafter referred to as the Party's "Maximum Contribution." Each Participating Entity will transfer its Maximum Contribution to a LARIAC account which has been established by the County for this Project (LARIAC Account) and as further described in Paragraph 5 of this Agreement.

The Maximum Contribution of the Participating Entity shall be \$27,434.

B. In the event the Project is terminated for any reason before the execution of any contract with a contractor for the provision of goods and/or services in connection with the Project, each Participating Entity shall be refunded its Maximum Contribution (or such portion of the Maximum Contribution as shall have been paid to the County by such Participating Entity) in its entirety.

5. Payment of Maximum Contribution; Administration of LARIAC Account

A. A Participating Entity shall have the following options in paying its Maximum Contribution to the County hereunder:

- i. The Participating Entity may elect to pay its Maximum Contribution to County in its entirety upon execution of this Agreement.
- ii. The Participating Entity may elect to pay its Maximum Contribution to County as follows: (a) fifty percent (50%) of the Maximum Contribution upon its execution of this Agreement; and (b) fifty percent (50%) upon delivery of the Digital Data to the Participating Entity.

B. The LARIAC Account established by the County in connection with the Project, shall be subject to the following:

- i. All funds held in the LARIAC Account shall be used solely for the payment of contractors selected by County to provide goods and services in connection with the Project.
- ii. Any funds held in the LARIAC Account not expended upon the completion of the Project or the termination of this Agreement shall be held, administered, and returned to Parties based on their prorated contribution to the total costs of the Project.

6. General Terms and Conditions

A. This Agreement shall take effect upon execution and shall remain in effect through final delivery of all Digital Data and through the duration of the license-use term.

B. The term of this Agreement may be extended by an Amendment to this Agreement.

C. It is the intention of the Parties that the Participating Entity shall receive, with the delivery of the Digital Data, an unlimited irrevocable perpetual, royalty-free license. The license may be used to, modify, edit, reuse, reproduce, translate, create derivatives, compile, other works based upon the Digital Data,

and combine the data with other contents selected by the Participating Entity in its own operation, with an unlimited number of seats; including, but not limited to Internet and intranet applications, copying, and printing.

D. The Participating Entity shall have the right to transfer, sublicense, and distribute any form of media either now known or hereinafter desired the Digital Data to its subcontractors or consultants on projects which are outsourced from its own operations. In this connection, the Participating Entity shall require each subcontractor or consultant to whom the Digital Data is transferred to execute a written acknowledgement and agreement to abide by such Participating Entity's license to use the Digital Data. Such acknowledgement and agreement is provided in Attachment B (Los Angeles Regional Imagery Acquisition Consortium (LAR-IAC) 6 Authorized User Confidentiality and Non-Disclosure Agreement).

E. Notwithstanding any provision of this Agreement to the contrary, a Participating Entity shall not have the right to sell, resell, or otherwise transfer its license to use the Digital Data to any other person or entity.

F. This Agreement may be amended or modified by County only after collaboration and consultation with the Participating Entities.

G. Nothing in this Agreement shall be construed to give any person or entity, other than the Parties hereto, any legal or equitable right, remedy, or claim under or in respect to this Agreement or any provision herein contained. This Agreement and the provisions hereof are intended to be and are for the sole and exclusive benefit of the Parties.

H. No Party may terminate its participation under this Agreement after the execution of contract(s) for the acquisition of the Digital Data without the prior written consent of County.

I. Any other California city, special district, agency, or educational institution may become a Participating Entity under this Agreement if:

- (i) Such entity executes this Agreement, and
- (ii) Such entity makes its Maximum Contribution to County as provided for under this Agreement. Any such contribution shall be deposited into the LARIAC Account and administered in accordance with subparagraph 5.B of this Agreement.

J. This Agreement may be executed in counterparts and the signed counterparts shall constitute a single instrument. The signatories to this Agreement represent that they have the authority to bind their respective party to this Agreement.

Pictometry International Corp., a Delaware company with offices at 100 Town Centre Drive, Suite A, Rochester, NY 14623 ("Pictometry"), and the County of Los Angeles ("County") have entered into that certain agreement dated December 3, 2013 ("Agreement") for delivery of licensed digital mapping data and software ("Licensed Products") to the County. Under the Agreement, certain governmental entities ("Authorized Entities"), including County Departments and non-County Authorized Participants, which participate in the LAR-IAC may be granted copies of or otherwise provided access to the Licensed Products through a Participant Agreement.
2. 3. The undersigned is an Authorized User of a County Department that is an Authorized Entity under the Agreement and desires to use the Licensed Products solely for internal, noncommercial use and for purposes no greater than reasonably needed to achieve the objectives of an actual project undertaken in connection with the relationship with the County Department ("Project").
4. The undersigned Authorized User understands and agrees that the Licensed Products contain trade secret and/or confidential information ("Confidential Information") of Pictometry. Therefore, by signing this Authorized User Confidentiality and Non-Disclosure Agreement ("NDA"), the Authorized User agrees to use the Licensed Products solely for the Project, which is a nonexclusive, nontransferable and non-assignable right, from the effective date of this NDA until the expiration or termination of the Project for which the undersigned Authorized User was engaged by the particular County Department.
5. To the extent any Confidential Information that is not in the public domain is revealed through the operation or other use of the Licensed Products, the Authorized User agrees that it will not make use of, disseminate or in any way disclose such Confidential Information without the County's prior written consent, which County may first need to obtain from Pictometry.

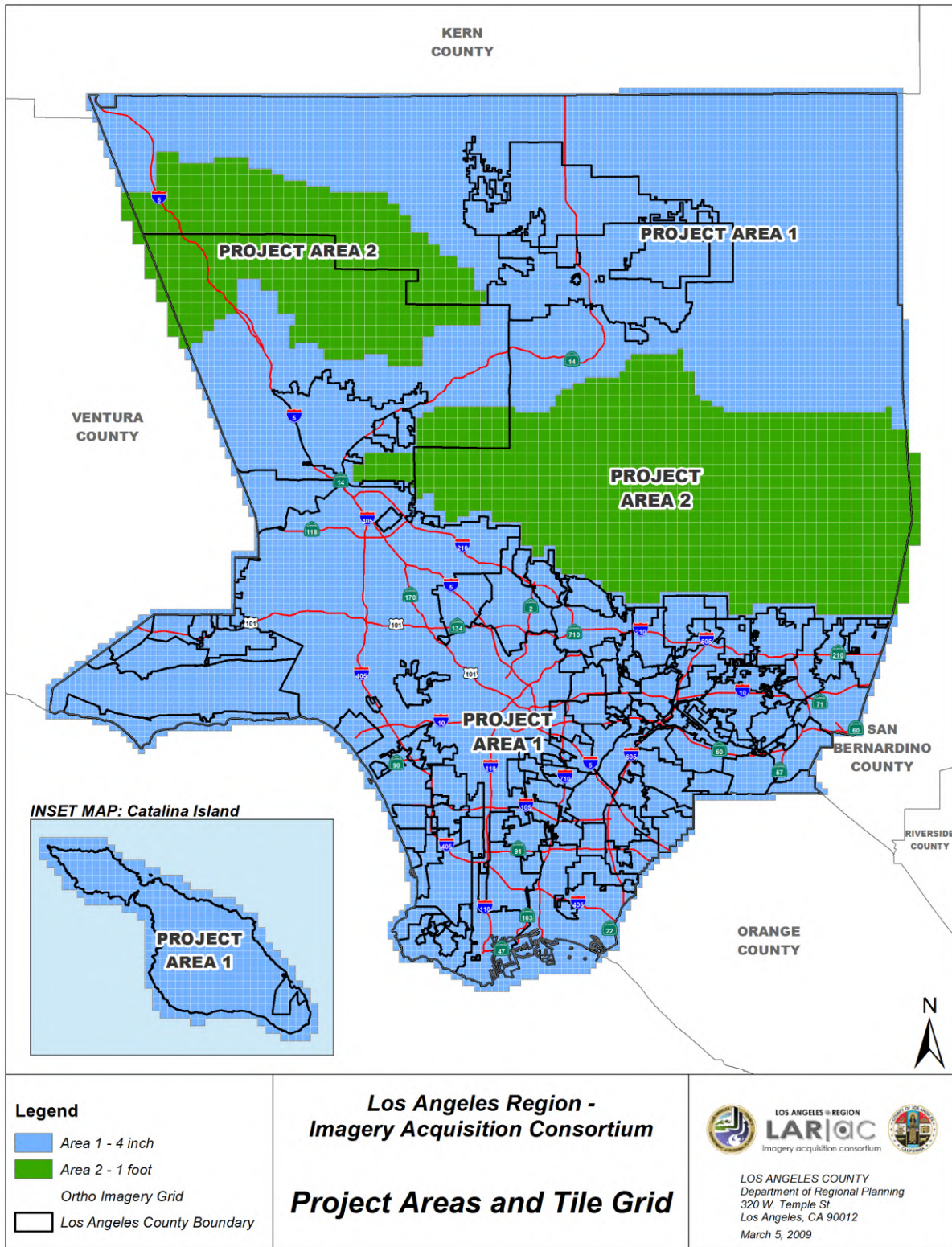

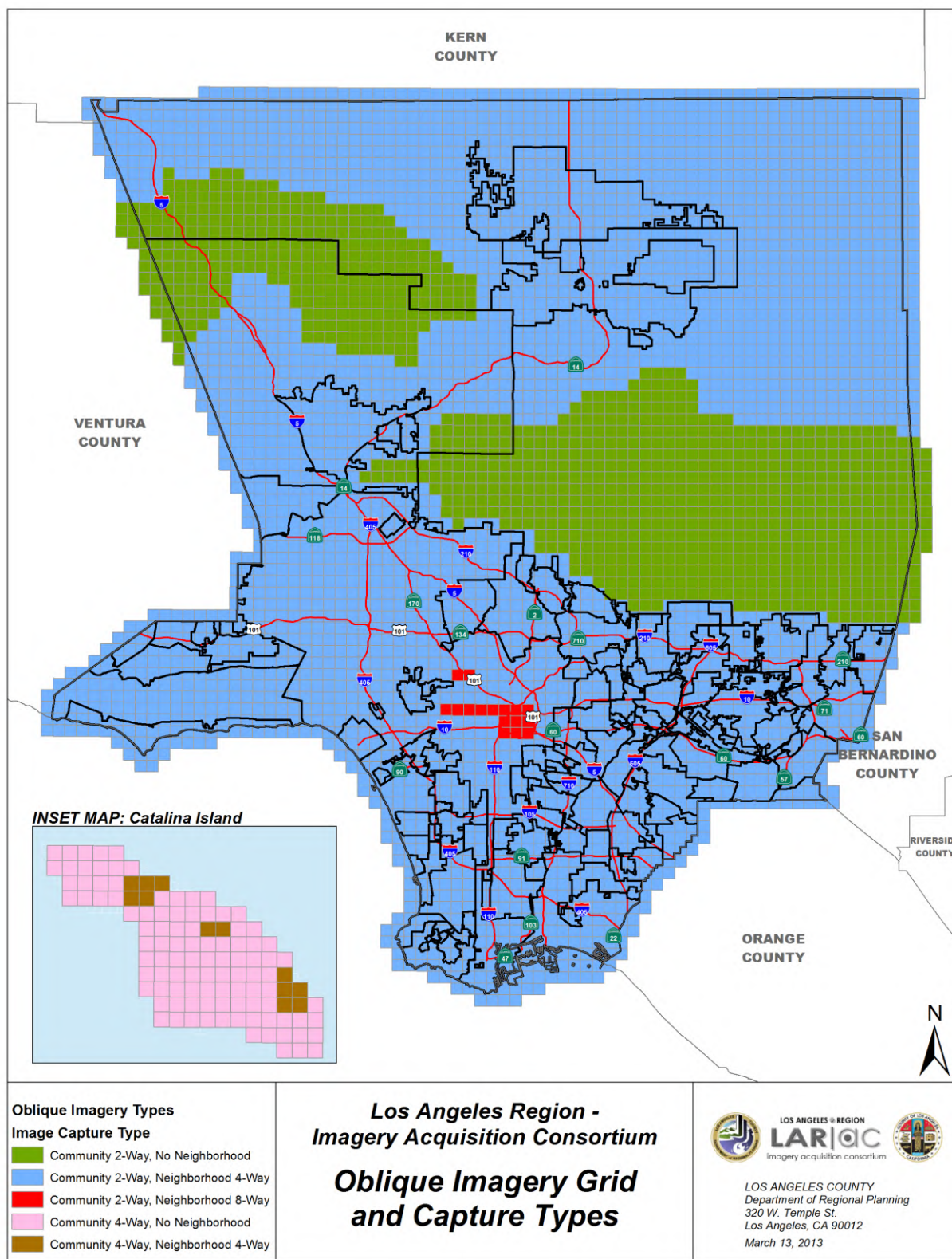

SUBJECT: Bid Award – Del Amo & Lakewood Intersection Improvements - PW Proj.15-04

INTRODUCTION

Bids have been received for a project to add a second left-turn lane in each direction at the intersection of Del Amo and Lakewood Boulevards. Currently, there is one left-turn lane in each direction. The project is entirely funded by Metro with their Measure R funds. There are no City of Lakewood funds required.

STATEMENT OF FACT

The intersection of Del Amo and Lakewood Boulevards was identified by Metro as a “Hot Spot” along the SR-91, I-605, and I-405 corridors that met requirements for funding. All Measure R funding is regional Measure R funds. No local Measure R funds are used.

The project will construct an additional left-turn lane in each direction, widen the east and west sides of the Lakewood Boulevard bridge as it crosses the open drainage channel south of Del Amo Boulevard, modify the traffic signals, landscaping, paving and other related work. Construction will begin in April 2020 and take about nine months.

The City Council has approved a Funding Agreement with Metro that provides \$5,504,300 in regional Measure R funds for this project. Willdan Engineering has provided Project Approval and Environmental Documentation and designed the project. Willdan has given the City a proposal to do construction management for an amount of \$429,941.

The City Clerk received and opened five bids for the proposed project on February 26, 2020. Following is the bid summary:

The lowest responsible bidder is Los Angeles Engineering of Covina in the bid amount of \$4,422,604.40. Staff has verified with the State Contractors License Board that Los Angeles Engineering is properly licensed for the work. Reference checks are satisfactory.

Construction is scheduled to begin in April, 2020 and be completed in January, 2021.

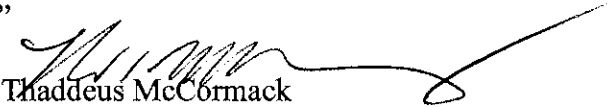
Based on the present budget amount funded by Metro, there are only \$67,370 available for construction contingency which is 1.5% of the construction contract amount. Depending on the complexity of a project, a contingency of 10 to 15% is normally allocated. Due to the size and complexity of this project, a contingency of \$500,000, which is 11.3%, is recommended. However, funds need to be available during construction of the project for possible contingency expenses. The recommendation is that the City Council approve temporary use of local Measure R for construction contingency up to an amount of \$500,000. Staff will proceed with a request to Metro to obtain additional regional Measure R funds. Metro staff indicates that the process will take about six months.

RECOMMENDATION

That the City Council:

1. Award a contract for "Del Amo & Lakewood Intersection Improvements - PW Proj.15-04" in the amount of \$4,422,604.40 to Los Angeles Engineering of Covina and authorize the Mayor to sign the contract in a form approved by the City Attorney.
2. Authorize staff to approve a cumulative total of contract change orders, as needed, not to exceed \$500,000.
3. Authorize temporary use of Local Measure R funds for construction contingency in an amount not to exceed \$500,000.
4. Authorize staff to execute Willdan's proposal to provide construction management for an amount of \$429,941.
5. Adopt the plans, specifications and working details for "Del Amo & Lakewood Intersection Improvements - PW Proj.15-04."

SUBJECT: Award of Bid for Public Works Project No. 2019-07
ADA Door Improvements to the Existing Centre and City Hall

INTRODUCTION

On March 2nd, 2020 the City Clerk received one bid for the ADA Door Improvements to the Existing Centre and City Hall project. The work generally consists of interior and exterior demolition, remodeling entrance door accessibility upgrades, and other improvements as required by the contract documents.

STATEMENT OF FACT

Three contractors qualified to bid this project by attending a mandatory pre-bid conference; two contractors purchased plans and specifications, and one submitted a bid proposal. A bid summary is below:

The lowest responsible bidder is Song N Sons General Construction Inc. in the lump sum base bid amount of \$151,000, which is below the engineer's estimate for this work. Staff has verified with the State Contractors License Board that Song N Sons General Construction Inc. is properly licensed for the work. References contacted by staff provided favorable comments on the quality of their work and they have completed similar installations for various public facilities. Staff also recommends that a slightly larger contingency of 20% be included, since there could be unforeseen, unexpected conditions, once the contractor begins demolition.

Staff recommends that Council waive a requirement in the standard specifications regarding the Contractor having to perform 50% of the work with their own forces. In this case, they have listed 85% of the work to be done by the door subcontractor and 15% of the work to be done by an electrical subcontractor. This project is solely for replacement of doors and storefront panels, which is typically subcontractor work in all larger building projects. These subcontractors do not usually submit prime bids. Song N Sons will be responsible for all supervision and compliance on the project.

Additional City Funding

An appropriation of \$510,000 from the Capital Reserve for ADA Improvements is necessary in order to complete the full scope of contract work, cover a 20% contingency during installation, cover the projected cost of the ADA parking improvements at the Civic Center and park sites, and cover the

The proposed appropriation would come from the reserve for Capital Improvements for ADA Improvements. \$1,000,000 was identified for this purpose, of which \$120,000 has been appropriated. Staff expects to make future appropriation requests from this reserve for path of travel improvements at the Civic Center and various parks, as well as additional ADA improvements for the Mayfair Pool locker rooms.

SUMMARY

Bids have been received on Public Works Contract 19-07. Staff recommends the contract be awarded to the lowest responsible bidder, Song N Sons General Construction Inc., that \$30,200 in project funds be authorized for contingency purposes, and that \$510,000 from the CIP Reserve for ADA Improvements be appropriated.

RECOMMENDATION

Staff recommends that the City Council:

- (1) Adopt the plans, specifications, and working details for the subject project.
- (2) Waive the requirement in the standard specifications that at least 50% of the work be done by the contractor's own employees.
- (3) Award a contract for the "ADA Door Improvements to the Existing Centre and City Hall", Public Works Contract 2019-07, in the amount of \$151,000 to the low bidder Song N Sons General Construction Inc. and authorize the Mayor to sign the contract in a form approved by the City Attorney.
- (4) Authorize staff to approve a cumulative total of change orders, as necessary not to exceed \$30,200.
- (5) Appropriate \$510,000 from the General Fund assigned fund balance -Capital Replacement and Repair.
