

SUBJECT: Quarterly Schedule of Investments

INTRODUCTION

Effective January 1, 1996, the California Government Code, Section 53646 requires that: *“The treasurer or chief fiscal officer shall render a quarterly report to the chief executive officer, the internal auditor and the legislative body of the local agency. The quarterly report shall be so submitted within 30 days following the end of the quarter covered by the report.”* In compliance with this section of the code, the schedule of investments is being rendered to be received and filed.

STATEMENT OF FACT

The investments represented in this report are allocated to a variety of funds such as the General Fund, Water Fund, Redevelopment Funds, Restricted Special Revenue Funds, and Fiduciary Funds.

The City’s idle funds are invested in compliance with the City’s investment policy, which was last reviewed and approved in January 2016 by the City Council, and is compliance with the updated Investment Policy proposed for adoption. Specifically, the city’s investment objectives in the investment of public funds are safety, liquidity and yield. To accomplish these objectives, the following types of investments have been chosen and the City is currently or in the past invested in the following securities:

Treasury Notes

TREAS Obligations of the U.S. Government to provide for the cash flow needs of the Federal Government.

Federal Agency Bonds or Notes:

Federal agency or United States government-sponsored enterprise obligations, participations, or other instruments, including those issued by or fully guaranteed as to principal and interest by federal agencies or United States government-sponsored enterprises.

- FHLB (Federal Home Loan Bank Bonds)
Bonds and discount notes issued by the Federal Home Loan Bank to provide funding to member institutions and make available money to the residential mortgage market.
- FHLMC (Federal Home Loan Mortgage Corp)
A publicly chartered agency that buys qualifying residential mortgages from lenders, packages them into new securities backed by those pooled mortgages, provides certain guarantees and then re-sells the securities on the open market.
- FNMA (Federal National Mortgage Association)

National Mortgage Association is a government-sponsored, privately owned corporation established to create a secondary market for Federal Housing Administration mortgages.

- **FFCB (Federal Farm Credit Bank)**

The Federal Farm Credit Bank is an independent agency of the U.S. Government which issues bonds and discount notes to provide short- and long-term credit and credit-related services to farmers, ranchers, rural homeowners, producers and harvesters.

Supra-National Agency Bond or Notes

Supranational debt is debt of international or multi-lateral financial agency; the debt is used to finance economic/infrastructure development, environmental protection, poverty reduction and renewable energy around the globe, rated AAA, highly liquid and issued in a range of maturities.

Negotiable Certificates of Deposit

Negotiable CDs are issued by large banks and are freely traded in secondary markets as short term (2 to 52 weeks), large denomination (\$100,000 minimum) CD, that is either issued at a discount on its par value, or at a fixed interest rate payable at maturity.

Municipal Bonds or Notes:

Registered treasury notes or bonds of any of the other 49 United States in addition to California, including bonds payable solely out of the revenues from a revenue-producing property owned, controlled, or operated by a state or by a department, board, agency, or authority of any of the other 49 United States, in addition to California.

Corporate Notes:

Medium-term notes, defined as all corporate and depository institution debt securities with a maximum remaining maturity of five years or less, issued by corporations organized and operating within the United States or by depository institutions licensed by the United States, or any state and operating within the United States. Medium-term corporate notes shall be rated in a rating category of “A” or its equivalent or better.

Commercial Paper:

Commercial paper of “prime” quality of the highest ranking or of the highest letter and number rating as provided for by a nationally recognized statistical-rating organization.

Pooled Funds:

LAIF (Local Agency Investment Fund, State of California)

This investment pool is administered by the Treasurer of the State of California, and provides a high-level of liquidity and strong safety through diversification of investments.

CAMP (California Asset Management Program)

A Joint Powers Authority established in 1989 by the treasurers and finance directors of several California public agencies to provide professional investment services at a reasonable cost. Participation is limited to California public agencies.

Investment in the Los Angeles County Pool may not exceed the current pool limits and should be reviewed periodically.

MMKT (Money Market)

This is a money market interest-bearing checking account that is fully insured and collateralized.



SUBJECT: Community Safety Commission Recommendation – “No Parking 11:00 p.m. to 7:00 a.m.” Del Hollow St Area

INTRODUCTION

The Community Safety Commission met on October 2nd, 2017 to consider various community safety matters that included the consideration of a request to install a “No Parking 11:00 p.m. to 7:00 a.m.” zone on various streets in Cherry Cove. The streets included in this request are Del Hollow Street, and a portion of Meadow Wood and Elderhall Avenues.

STATEMENT OF FACT

Staff received a request from a resident to install “No Parking 11:00 p.m. to 7:00 a.m.” on various streets around her residence on Del Hollow Street, and on portions of Meadow Wood and Elderhall Avenues. The resident requested the parking restrictions because of limited parking, suspicious activity, and littering caused by tenants of the nearby apartments in Long Beach. Staff gave the requesting resident a sample petition with the understanding that she was responsible for obtaining signatures. She secured signatures from the residents at the addresses that would have the parking restrictions in front or on the side of their houses. Part of the requirement was that signatures had to be obtained continuously for residences; that is, the zone could not skip a residence and then start again. The residents were aware that no vehicle parking would be allowed in this zone during the posted timeframe, and that any vehicle parked in the zone during these hours may be cited and fined. On October 2nd, the Community Safety Commission approved the request to install a “No Parking 11:00 p.m. to 7:00 a.m.” zone, based on Staff recommendation.

RECOMMENDATION

The Community Safety Commission recommends that the City Council adopt the attached resolution authorizing the installation of “No Parking 11:00 p.m. to 7:00 a.m.” on Del Hollow Street, and on portions of Meadow Wood and Elderhall Avenues.

SUBJECT: Request for Approval of Substitution of Sub-Contractor
Public Works Contract 16-01R
Improvements to the Existing Burns Community Center

INTRODUCTION

On June 27, 2017 the City Council awarded a contract to De La Riva Construction for the Improvements to the Existing Burns Community Center project. One of the sub-contractors listed in the original bid documents has refused to sign a contract with De La Riva Construction. Approval to substitute the listed sub-contractor with the replacement subcontractor Rainbow Glazing, Inc. is requested.

STATEMENT OF FACT

De La Riva Construction entered into a contract on June 27, 2017 with the City for Public Works Contract 16-01R, and began notifying all listed sub-contractors of the award and their obligation to sign sub-contracts. The sub-contractor – Summit Glass – was listed for the automatic door system and storefront system. Now that the work is ready to begin, this sub-contractor has refused to sign the contract for the scope of work, and has failed to respond to correspondence from De La Riva Construction regarding the project.

Public Contract Code Section 4107 identifies seven conditions under which a general contractor can request approval to substitute a sub-contractor. One condition is “when a sub-contractor listed in the bid, after having had a reasonable opportunity to do so, fails or refuses to execute a written contract...when that written contract...is presented to the sub-contractor by the prime contractor.” De La Riva intends to have Sub-Contractor Rainbow Glazing Inc. perform the work. A notice was sent on October 18, 2017 notifying Summit Glass of the substitution request, as required by the Public Contract Code. This sub-contractor substitution will require no change in Contract Price, and no additional costs to the City.

RECOMMENDATION

Staff recommends that the City Council:

Approve the request for substitution of Summit Glass with Rainbow Glazing Inc. as submitted by De La Riva Construction, the General Contractor for “Improvements to the Existing Burns Community Center” Public Works Contract 16-01R.

On October 9, 2017, the Purchasing Officer, in the presence of the City Clerk, opened three sealed bids. The Purchasing Officer and the IT Services Manager reviewed the bids to determine that specifications had been successfully met and the bid totals were accurate.

A summary of the three bids received is as follows. Sales tax is not applicable, as the City will download the licenses.



ORDINANCE NO. 2017-8

AN ORDINANCE OF THE CITY OF LAKEWOOD MOVING THE CITY'S GENERAL MUNICIPAL ELECTIONS TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN MARCH OF EACH EVEN-NUMBERED YEAR BEGINNING IN MARCH OF 2021

WHEREAS, City of Lakewood (the "City") general municipal elections are now held in March of odd-numbered years, to elect five members of the City Council, with three members elected in one year and two members elected two years removed; and

WHEREAS, the provisions of Senate Bill 415 (SB 415) compel the City to consolidate its general municipal elections with a statewide election date, not later than November, 2022; and

WHEREAS, Sections 1301 and 10403.5 of the California Elections Code authorize the City Council to reschedule its general municipal elections to increase or decrease any terms of office by not more than 12 months.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD DOES ORDAIN AS FOLLOWS:

SECTION 1. Change of Election Dates. Pursuant to Sections 1000 and 1301 of the California Elections Code, the City's general municipal elections are hereby moved to the first Tuesday after the first Monday in March of even-numbered years, to coincide with statewide general elections, commencing with the moving of the general municipal election presently scheduled for March, 2021, to March, 2022.

SECTION 2. Adjustment to Terms of Office. Pursuant to Section 1301 and 10403.5 of the California Elections Code, the term of any elected City officeholder that would have expired in March, 2021, shall instead expire in the same manner, but after the occurrence of the general municipal election to be held in March, 2022, and the term of any elected City officeholder that would have expired in March, 2023, shall instead expire in the same manner, but after the occurrence of the general municipal election to be held in March, 2024.

SECTION 3. Section 1500 of the Lakewood Municipal Code is hereby amended to add the following additional paragraph to follow the existing language in said section:

"Beginning in 2021, the date of the general municipal election is changed to the first Tuesday after the first Monday in March of even-numbered years, with the first such change being that the election that otherwise would have been held on March 2, 2021, will instead be held on March 8, 2022."

SECTION 4. Consolidated Elections. Pursuant to Section 1301 and 10403.5 of the California Elections Code, the City hereby requests that the County of Los Angeles approve this Ordinance and allow for the consolidation of the City's general municipal elections with statewide

general elections to be conducted by the County in March of each even-numbered year, beginning with the election to be held in March, 2022. The City Clerk is hereby directed to forward a copy of this Ordinance to the Los Angeles County Board of Supervisors with a request that it be approved.

SECTION 5. Operative Date. This Ordinance shall become operative upon approval by the Los Angeles County Board of Supervisors.

SECTION 6. Notice to Voters. Pursuant to Section 10403.5(e) of the California Elections Code, within 30 days after this Ordinance becomes operative, the City's Elections Official shall cause notice to be mailed to all registered voters, informing the voters of the change in election dates made by this Ordinance, and that, as a result of such change, the terms of office of City officeholders will be extended by not more than 12 months.

SECTION 7. The City Council hereby declares it would have passed this Ordinance sentence by sentence, paragraph by paragraph and section by section, and does hereby declare the provisions of this Ordinance are severable, and if for any reason any section of this Ordinance should be held invalid, such decision shall not affect the validity of the remaining parts of this Ordinance.

SECTION 8. The City Clerk shall certify to the adoption of this Ordinance. The City Council hereby finds and determines there are no newspapers of general circulation both published and circulated within the City and, in compliance with Section 36933 of the Government Code, directs the City Clerk to cause said Ordinance within fifteen (15) days after its passage to be posted in at least three (3) public places within the City as established by Ordinance.

SUBJECT: Halloween Carnivals

INTRODUCTION

Halloween carnivals featured at eight parks throughout the city are among the most well attended city events of the year. It is estimated that over 15,000 children and adults will participate in this year's annual event on Tuesday, October 31 from 6 to 8:30 p.m.

STATEMENT OF FACTS

Halloween carnivals have been a Lakewood tradition since 1956 when Mayfair Park hosted the first city-wide event. In 1957, three additional carnivals were coordinated at Bolivar, San Martin, and Del Valle Parks. Halloween attractions were later added at Biscailuz, Bloomfield, Boyar, and Palms Parks, thus creating a safe destination within walking distance of most neighborhoods in the city.

Carnival elements, including game booths and decorations, are centered on a popular theme that is quickly recognized by preschoolers and elementary school-age children. More common themes are related to popular movies and cartoon characters widely adored by youngsters. This year's themes are listed below.

- "California" – Biscailuz Park
- "Marvel/DC Superheroes" – Bolivar Park
- "A Spooky Halloween" – Mayfair Park
- "Peanuts" – San Martin Park
- "Lego Batman" – Boyar Park
- "Disney Villains" – Del Valle Park
- "Moana" – Bloomfield Park
- "Super Mario Bros" – Palms Park

Collectively, carnival elements feature over 200 game booths for preschool and school-age children. Game booth participants are awarded age-appropriate candy or a novelty prize for their participation. Specialty contests are also scheduled throughout the evening. The highlight of the evening is a costume contest and parade beginning at 7 p.m. at each carnival location. The showcase of costumes provides a stage for participants of all ages to be recognized for their individualism in costume selection.

A “Red Ribbon Booth” to promote a drug free society has become a carnival staple since the early 90s. Children of all ages can play a carnival game inside the booth and win a selection of prizes promoting a drug free message.

Appropriately scary haunted houses are a popular attraction at Bolivar, Del Valle, Palms and San Martin Parks. Haunted houses are specially designed for children 6 to 11 years old and will be open from 6 to 8 p.m.

To further augment and support the larger attendance at Mayfair and Bolivar Parks, inflatable attractions will complement the carnival. These affordable fee-based attractions have become a main event component since the department introduced the concept in 2007.

The success of each carnival is dependent upon the assistance received from the Lakewood community. It is anticipated that over 400 volunteers will provide over 2,200 hours of service in working more than 200 game booths. Sources of volunteers throughout the community include Lakewood service organizations, church groups, and student organizations from area high schools and colleges.

Communicating this safe alternative for Halloween night is an important planning element. Vinyl banners are on display at the park facilities where carnivals are scheduled. Special event flyers were distributed to students at Lakewood’s elementary schools and are available at city facilities and Lakewood’s libraries. Lastly, printed press and complementary photos were published in the RCS fall catalog, the Lakewood Living Magazine, the Lakewood Community News and online in Lakewood’s e-Magazine. The combination of all these communication mediums ensures that residents have been thoroughly informed about the continued tradition of Halloween carnivals at city parks.

RECOMMENDATION

Staff recommends the Mayor and City Council receive and file the report.
